Buy-in Information

You are eliminated from the tournament when you lose **all** your chips. The tournament will not stop, except for short breaks, until one player holds all the chips. That player will be declared the 1st place finisher. The last player eliminated will be the second place finisher; the second last player eliminated will be the 3rd place finisher, etc.

During the **first hour** of the tournament you may 're-buy' after you have lost all your chips for \$30. Only one re-buy per player per tournament.

Late players: If you have reserved a seat but do not show up in time, you will be assigned a seat and chips. Your blinds will be posted in your absence.
